

Honolulu Pride Festival 2022 <u>Festival Food Vendor Agreement</u> Booth Space Terms and Conditions

Date and Location of Event:

Saturday, October 15, 2022 / Waikīkī Shell / Diamond Head Greens

Food Vendor Booth Space (vendor subject to approval):

No booth sharing is permitted, and booths are limited to a 10 ft. x 20 ft. space. A vendor may supply their own tent, tables and chairs or rent the items from the festival for an additional fee.

Signs/Banners:

The sum of all signs and banners cannot exceed 18 square feet per vendor space and must be in good taste. Signs and banners exceeding the size requirements or determined to be in bad taste as determined by the Hawai'i LGBT Legacy Foundation or Enterprise Services officers must be removed upon notification.

Vendor Entry:

Vendors will be provided 4 Wrist Bands at no charge that will allow entry through the VIP Entrance or Service Entrance during set-up. Additional Wrist Bands may be purchased for \$20 each.

Setup & Breakdown:

• Day before the event- Friday, October 14th from 2:00 - 6:00 pm early set-up. Vehicles enter through Service Entrance only. *Set-up as much as possible the day before is encouraged due to high traffic volume Saturday!*

• Day of the event– Saturday, October 15th set-up begins at 7:00 am. Vehicles may enter through Service Entrance but *are not permitted to park in the Service (backstage) Parking Lot under any circumstance*. Foot traffic is permitted through VIP Entrance or Service Entrance. Gates close at 10:45 am so all vehicles must be out of gate and to assigned parking lot. Booths must be set up by 11:00 am. Gates open at 11:30 am to the public. Festival Ends at 5:30 pm. Vehicle access will be restored at 6:00 pm for breakdown and must be pau by 7:00 pm.

Food Vendors Must Provide the Following (within 2 weeks of registration):

• Must provide proof of a general excise tax license.

• Vendor must furnish a food menu with prices for approval.

• Vendor may not sell or give away any beverages without written approval of the Hawai'i LGBT Legacy Foundation (no soda or water, specialty drinks only).

• Vendor must provide a Department of Health temporary food establishment permit application.

• Vendor must provide two (2) trash cans at their booth and remove their trash from the facility. Failure to remove trash will result in a \$150.00 fee

Insurance:

• Vendor must provide a certificate of liability insurance showing coverage for comprehensive general liability insurance including products liability with a minimum limit of no less than \$300,000 bodily injury, per occurrence and \$10,000 property damage, per occurrence listing the Hawai'i LGBT Legacy Foundation and the City and County of Honolulu as additional insureds.

Liability:

• The vendor shall indemnify, defend, and forever hold the Hawai'i LGBT Legacy Foundation and their volunteers, as well as their sponsors harmless from and against all claims, and actions for personal injury, death, property damage or other legal damage/claims which may be sustained by any and all vendors as a result of and in conjunction with other vendors involved in the above referenced activity, together with any loss, cost, expense including and without limitations, court costs, and attorney fees which the Hawai'i LGBT Legacy Foundation may sustain as a result of the event, including limitations, claims by the vendor's own worker employees or other parties against the aforementioned organization.
